UGI Utilities, PNG and CPG have been consolidated by merger effective October 1, 2018, with UGI Utilities as the surviving entity. The gas utility serves more than 642,000 customers in 45 eastern and central Pennsylvania counties and one Maryland county. UGI Utilities provides electric utility service to more than 62,000 customers in Luzerne and Wyoming counties in northeastern Pennsylvania through over 2,200 miles of transmission and distribution lines and 13 substations.

UGI Energy Services, LLC supplies and markets natural gas, electricity and liquid fuels to approximately 35,500 residential, commercial and industrial customer locations across the mid-Atlantic and northeastern United States.
